How's that possible? With January 1st, 2013 our contract with the German GEMA (a royalty-fee-collector) ran out and by this date we decided to release all our recordings under the Creative Commons Attribution-Non-Commercial-ShareAlike 3.0. unported license.

This allows you to:

to Share — to copy, distribute and transmit the work (for all the listeners outside)

to Remix — to adapt the work (for all the artists outside)

Conditions:

Attribution — You must attribute the work in the manner specified by the author or licensor (but not in any way that suggests that they endorse you or your use of the work).

Noncommercial — You may not use this work for commercial purposes.

Share Alike — If you alter, transform, or build upon this work, you may distribute the resulting work only under the same or similar license to this one.
